Guest Speaker

1. **President's Welcome**: Tracy Mulligan welcomed those present and introduced Captain Cathell (see Attachment 1 for the meeting agenda).

2. **Bethany Beach Police Department Presentation**: Captain Cathall covered the following in his remarks

- Overview of BBPD: Small agency which has 10 Full Time Officers, one civilian employee and 15 seasonal officers. BBPD Officers have impressive credentials. BBPD carries out a unique vetting and training process for seasonal officers that leads to top summer hires. The process and is well regarded by other jurisdictions. BBPD is one of only 6 of 52 Delaware agencies to be accredited by the Commission for Accreditation of Law Enforcement Agencies (CALEA).
- BBPD covers 100 special events per year, with the season extending beyond the traditional summer months
- BBPD has upgraded its vehicles and equipment using funds from the town and grants. This includes SUV vehicles which operate as fully-equipped mini-offices; patrol rifles and gear which allow officers to respond to active threat situations; body cameras for all officers.
- BBPD focuses on prevention. This include patrol and visual deterrents; a focus on bike safety, including for foreign workers; partnering with Sea Colony kid's camps; partnering with state special initiatives (like cell phone patrols).
- New reality is the need to be prepared for terrorism and domestic active shooting incidents. This includes maintaining communication with the FBI, which is the main responsible agency for terrorism. Practice on responding to domestic active shooting incidents has changed over the years, and officers are now trained to be immediate responders (not relying on external swat teams), and have the necessary equipment, with

new protocols for paramedics. Citizen help to prevent incidents by being alert and reporting concerns is needed.

Several audience members commented that they were very impressed by the presentation which highlighted the proficiency and professionalism of the BBPD. Questions raised included: whether Bethany Beach is experiencing the heroin epidemic (A: this is mainly an issue in Ocean View, and is related to 80% of break-ins); how are incidents linked to mental illness handled (A: BBPD relies on "Mobile Crisis" support to provide guidance); who covers adjacent areas like north of Bethany or Sea Colony which are outside of BBPD's jurisdiction (A: State Patrols, with BBPD providing cooperative back-up).

- 3. **Annual Meeting called to Order** by President Tracy Mulligan at 11 a.m. with a quorum of over 15 members established.
- 4. **Approval of the Minutes of the 2016 Annual Membership Meeting**: Approval of the 2016 Minutes was moved and seconded.

VOTE: Unanimous approval of the Minutes of the 2016 Annual Membership Meeting.

- 5. **Treasurer's Report**: Patrick McGuire reported on the financial status of the BBLA, which is strong (see Attachment 2).
- 6. **President's Report**: Tracy Mulligan presented the President's Report (see Attachments 3a&b). This covered:
 - Activities of the Board in each of the four main purposes of BBLA as stated in 1969 and remaining since then (Charitable, Communications, Advocacy to present views, History), as well as historical background on BBLA's Charitable Donations.
 - Brief update on beach replenishment.

7. Nominations and Elections:

8. **Approval of By-Law Amendments**. The By-Law Committee worked over the last year and made several recommendations for amendments. These were sent to members by email, or US mail for the 10% without e-mail, and posted on the BBLA website over 30 days in advance of the meeting.

The Floor was opened for questions. There were none. A motion was made and seconded to approve the Amendments to the By-Laws.

VOTE: Unanimous approval of the By-Law Amendments.

10. **Question-and-answers included**: A request for more information on recipients of Charitable Donations (A: the President outlined the recipients); the link between the BBLA and the Town Council (A: while these are separate entities with distinct roles and governance -- the Town Council is an elected body with statutory obligations, BBLA is a voluntary membership organization -- the two work respectively together); the cost associated with the Annual Dues Appeal (A: mailing, with a newsletter, to all member and non member households in the Town, prepaid postage for members to renew, and printing); a discussion of the advocacy needed on beach replenishment, especially on concerns related to the engineering aspects of the beach shoreline (A: the BBLA does not have a role on design which is the purview of the Army Core of Engineers).

- 11. **Appreciation:** President Mulligan expressed the BBLA's thanks for their years of Board and officer service to Robin Baxter and Jerry Morris. Robin resigned as she in the process of selling her Bethany home, since her children moved to the West Coast. Jerry resigned after he was elected as treasurer for the Town
- 13. **Adjournment:** After a motion was made and seconded, a VOTE was unanimous to adjourn and the BBLA 2017 Annual Meeting was adjourned at 11:50 a.m.

- 1) Revenues until the end of the year will be minor. Perhaps some small number of additional members plus some revenue from brochure sales for a total of less than \$500.
- 2) The major monetary move in 2017 was the closing of our Business Premium MM account at PNC and the transfer of the funds to our Checking account on 4/3/17 of \$18,562.56. We were earning 30 cents a month and it is now easier to understand our total financial position.
- 3) The other distortion to our expenses is the \$12,000 donated to eight charities last month. This is often done in the second half of the year. We had fallen behind our typical donation pace during the past three years so there was an element of catch up this year.

Attachment 3b: Historical Background on BBLA's Charitable Donations

Historical Background on BBLA Charitable Donations

BBLA Annual Meeting – June 17, 2017

BBLA has a tradition of charitable giving that goes back to its start over 48 years ago.

In 1969, the certificate of incorporation stated "The purposes for which this corporation is organized is to carry on chartable, educational, and civic work for the improvement of Bethany Beach". That overall wording has remained in every update of the bylaws. Specific bylaws language has always included "to collect and disseminate information", "to present the views of its members and of the Association", and "to preserve the historic character of Bethany Beach." In other words, the purposes were charitable, communications, advocacy, and history.

- Going back 28 years, the 1989 BBLA newsletter cited a donation to the volunteer fire department and the discussion to start the South Coastal Library
- From 2009 to 2012, BBLA averaged \$6000 per year in donations to other organizations. During 2013 to 2017, the average was \$4000 per year, with most years lower.
 - The reduction occurred because the Board responded to results of a member survey on BBLA priorities, because the Board shirted resources to increase its electronic communications capability, and to build reserves. As membership and revenues increased, the proportion utilized for donations decreased.
- There was also a shift in the organizations receiving BBLA donations.
 - o In the 2009-12 period, these were mostly to the Volunteer Fire Dept, the South Coastal Library and the Fourth of July Parade Committee.
 - O As the three main recipient organizations became larger and received greater government funding, the Board shifted to allocating the lower level of donations to smaller organizations. For example, donations to the Bethany Beach Farmers Market and Operations Seas the Day made a difference in these organizations' early days.
- Three years ago the President established a donations policy committee of the Board to recommend criteria for a donation process and award criteria. The Board approved a policy, implemented it for a year, revised it, and then implemented it for a second year. One learns a lot about a policy when actually using it.
- The Board may again seek member views on two areas. One is the relative priority of charitable donations among BBLA's purposes. The other is input on the criteria to use in approving a donation, in general and possibly by using specific examples.
