Part of the traditional process of running for Bethany Beach Town Council is receiving a list of questions from BBLA (the Bethany Beach Landowners Association). On behalf of John Himmelberg, President of BBLA, I am sending you this year's list and asking for your response by Aug 1.

BBLA sends the candidates' answers to all town households in a newsletter. Each candidate receives the same questions; the answers are published exactly as provided by the candidate. The newsletter goes to all 2700 households which contain the approximately 4500 eligible voters.

- 4. **Rezoning**. Are you for or against the proposed Commercial Lodging (CL-1) rezoning? Please explain your position.

Please respond by 4 PM on Thursday Aug 1. If that timing presents a problem, please contact me as early as possible. Have no more than one page, approximately 500 to 600 words. If there are questions, please contact me at this e-mail or by phone or text on 240-687-3841.

Tracy and I have been working possible questions to pose to candidates for Town Council in the event there is a contested election. We are now at the point at which we feel it would be useful to have the Board review the draft. However, to avoid any possible appearance of favoritism, we want to make sure that all the candidates receive the questions at the same time so that no candidate has more time to prepare responses than other candidates.

One or more Board members may be running or at least still thinking about running, and we want to make sure that any such Board member is not given a head start on answering the questions. The Candidates Newsletter is assembled and formatted into a single word document, and is sent to John Barrett at the UPS Store in Ocean View. John formats it and sends it back to the BBLA contact for final review and OK. We alert John in advance as it typically takes one to close to two weeks to get it out.

Also sent is the tax list from the Town of Bethany Beach that shows all citizens of the town. The town supplies it for a reasonable fee (\$50 in the past). It is an electronic list
